Tony Hendricks opened to explain what Habitat for Humanity is looking to do with the lots. In splitting them and furthering their plans with the lots they would save 3 times the amount of runoff that the previous lots have had in the past.

Chairperson Jerry Jackson asked the question on if all the foundations have been removed in that area. Tony Hendricks responded stating that "Yes, all the foundations have been removed."

Mr. David Porter asked if the plan was to build something similar to what was built over by Parks School. Jeff Alborn answered with "that is the plan, to have it very similar to what happened over at Parks School."

Chairperson Jerry Jackson then asked Jeff to explain what Habitat for Humanity does for the community.

Jeff then explained how their organization helps the citizens with housing and then explained the process. Where people will submit an application and once a family is select the family must put in 250 hours of sweat equity (help build their house or someone else's). Then once their house is built, they tie the house mortgage to their income with a zero percent interest mortgage for so many years. If they get more volunteers the house mortgage can be lowered.

Chairperson Jerry Jackson asked if there were any comments from the public. There was no comment.

Jerry Jackson then asked for discussion. There was no discussion.

David Heinold then came up front to explain what it is that is being discussed. In re subdivide the 4 lots into 5 new lots. David also gave

dimensions on how big the lots would be. David then explained in the Muni code what is allowed and the process on how to get lots subdivided.

Mr. Paul Vincent made a motion to approve a 5-lot re-subdivision preliminary plat. Mr. David Porter 2nd the motion and the motion passed 6 to 0.
