Introduction of a Resolution Approving Use of a Tax Abatement on Real Property Taxes Created by the Construction of a New Senior Living Facility

Councilman Franke moved to introduce a Resolution; motion seconded by Councilwoman Feikes and unanimously carried. Councilman Franke read a Resolution Approving Use of a Tax Abatement on Real Property Taxes Created by the Construction of a New Senior Living Facility in its entirety.

Bert Cook, Executive Director of the La Porte Economic Advancement Partnership, reported Ed Arnold and John English who are the principals of this project are present here tonight. He stated this is 48,000 square foot senior living center at a cost of \$16,000,000. Mr. Cook reported about sixty beds will be for assisted living and another 30 beds for memory care and will employ about 50 people. He stated this project has been a long process and the water infrastructure as it currently stands was not sufficient for this type of project. Mr. Cook stated, as you all are aware, public infrastructure work will need to be completed for this project. He reported the County is willing to help with some of those improvements.
